



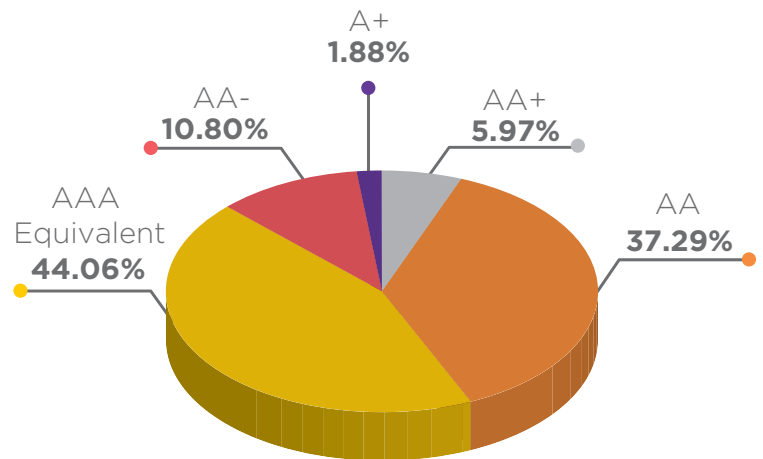
## IDFC CREDIT RISK FUND

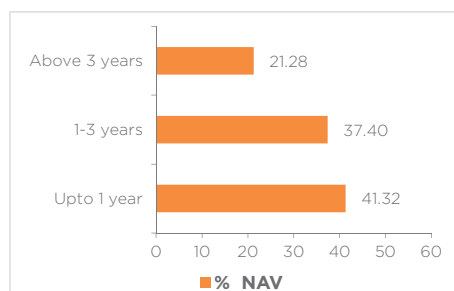
