

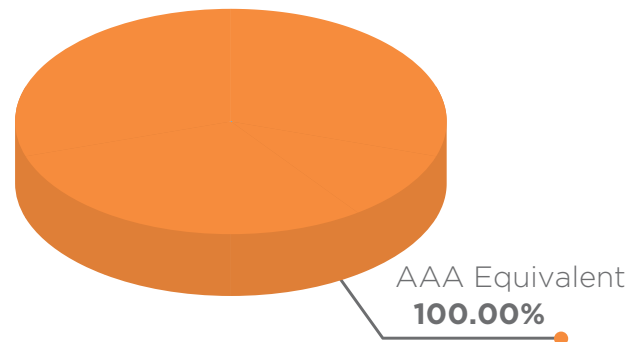


IDFC MONEY MANAGER FUND
