

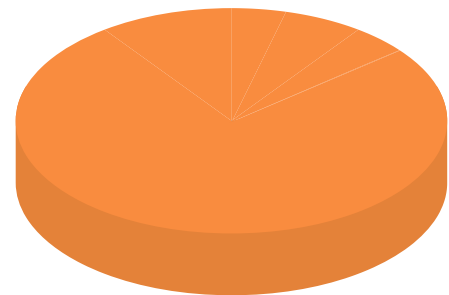


IDFC CASH FUND

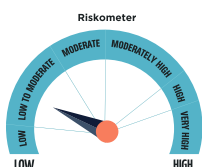
