

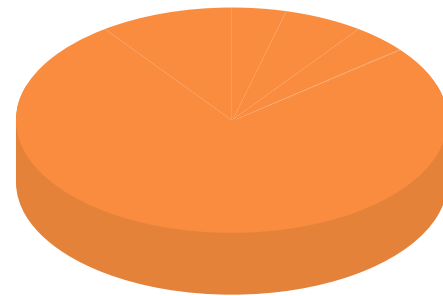


IDFC CORPORATE BOND FUND

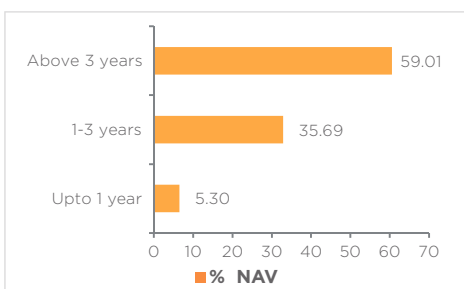

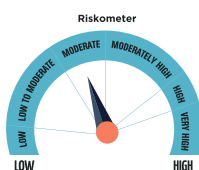
