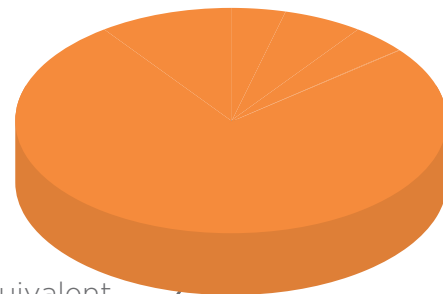
CORE



